Introduction

I am writing to you with details of this year's Annual General Meeting ("**AGM**") of the Company to be held at 10:30 a.m. on 20th November 2024 at the offices of Druces LLP, Salisbury House, London Wall, London EC2M 5PS. The Notice of this Annual General Meeting is set out on pages 5 to 8 of this document.

This letter also explains why the Directors recommend that shareholders of the Company (the "Shareholders") vote in favour of the resolutions being proposed at the AGM (the "Resolutions").

Explanatory notes to the Notice of AGM

The following notes give an explanation of the proposed Resolutions. Resolutions 1 to 4 (inclusive) will be proposed as ordinary resolutions. This means for each of those Resolutions to be passed, more than half of the votes cast must be in favour of the Resolution. Resolution 5 will be proposed as a special resolution. This means that for Resolution 5 to be passed, at least three quarters of the votes cast must be in favour of the Resolution.

Resolution 1 – Receiving and Considering the Accounts

This is an ordinary resolution to receive and adopt the annual accounts of the Company for the financial year ended 31 March 2024 together with Directors' reports and auditors' report on those accounts.

Resolution 2 – Re-election of Director

The Board recommends the re-election of Timothy Hargreaves as a Director of the Company who is retiring by rotation pursuant to article 83 of the Articles of Association of the Company (the "Articles"). Mr. Hargreaves being eligible, offers himself for re-appointment.

Resolution 3 – Appointment of Auditors
